The undersigned hereby makes, constitutes and appoints Su-Lynn Choy, with full power of substitution, re-substitution and delegation, the undersigned's true and lawful attorney in fact (this person and her substitutes and delegates being referred to herein as the "Attorney-in-Fact"), with full power to act for the undersigned and in the undersigned's name, place and stead, in the undersigned's capacity as an officer, director or stockholder of Maxeon Solar Technologies, Ltd. (the "Company"), to:
